# इंडिया आर्थिक शक्ति के रूप में उभर रहा, पर नौकरी, सुधारों के मोर्चे पर स्थिति अच्छी नहीं : सुब्बाराव

भारतीय रिजर्व बैंक के पूर्व गवर्नर डी सुब्बाराव ने कहा है कि नरेन्द्र मोदी सरकार के 11 साल के कार्यकाल के दौरान मजबूत आर्थिक वृद्धि, राजकोषीय स्थिति और महंगाई दर में नरमी के साथ भारत आज आर्थिक शक्ति के रूप में उभर रहा है, लेकिन अच्छी नौकरी सृजित करने, मेन्यूफेक्चरिंग और अगली पीढ़ी के सुधारों को आगे बढाने के मोर्चे पर स्थिति अच्छी नहीं है।

सब्बाराव ने कहा, ''आज, 11 साल बाद, आर्थिक वृद्धि मजबूत है, मुद्रास्फीति नरम हुई है, रुपया स्थिर है, बाह्य क्षेत्र मजबूती दिखा रहा है, राजकोषीय स्थिति बेहतर है और फंसे कर्ज की समस्या समाप्त हो गयी है। हालांकि, शुल्क बाधाओं और बिगडते भू-राजनीतिक तनावों से कई वैश्विक बाधाएं और अनिश्चितताएं उत्पन्न हुई हैं, बावजूद इसके

## राजस्थान : रेगिस्तानी इलाकों में सौर ऊर्जा संयंत्र स्थलों पर 'खेजडी' की हो रही कटाई

जयपुर@नयी दिल्ली। थार रेगिस्तान की कठोर जलवायु परिस्थितियों में अस्तित्व का प्रतीक और राजस्थान के राज्य वृक्ष का दर्जा प्राप्त 'खेजड़ी' (प्रोसोपिस सिनेरिया) अब अपने वजूद की लडाई लड रहा है। खेजडी को एक और अमृता बिश्नोई की तलाश है, जिन्होंने 1730 ई. में इन वक्षों की रक्षा के लिए अपने प्राणों की आहति दे दी थी 'राजस्थान का गौरव' और रेगिस्तान के 'कल्प वृक्ष' के रूप में जाना जाने वाला खेजडी 'रूट बोरर' नामक जीव और फफूंद संक्रमण के चलते सूखने के कारण लंबे समय से अपने अस्तित्व के लिए संघर्ष कर रहा है। हालांकि, पिछले कुछ वर्षों से यह मानव जनित खतरे – सौर संयंत्र – के कारण प्रभावित हुआ है, जिसकी वजह से इन पेड़ों का बड़े पैमाने पर सफाया हो रहा है। यह खतरा उस समय और बढ़ हो गया जब पिछले वर्ष फलौदी जिला प्रशासन ने बाप तहसील के अंतर्गत बड़ी सिड में सौर संयंत्र स्थल पर दबे 47 खेजड़ी के पेड़ बरामद किए। पेड़ों की अंधाधुंध कटाई के खिलाफ फलौदी में प्रदर्शन करने वाले विभिन्न बिश्नोई संगठनों के कार्यकर्ताओं ने दावा किया कि उनके पास उपग्रह से ली गईं तस्वीरें हैं जो उनके इस दावे की पुष्टि करते हैं कि जैसलमेर, फलौदी, जोधपुर और बीकानेर जिलों में सौर संयंत्रों के लिए हजारों बीघा भमि साफ की गई है। इस सप्ताह के आरंभ में जोधपुर के निकट ओसियां से भी इसी प्रकार के प्रदर्शन की खबर मिली थी, जहां अन्य प्रजातियों जैसे रोहिड़ा के साथ-साथ खेजड़ी के लगभग 150 पेड़ों को काटा गया था, जिसके फूल को राजस्थान में राज्य पुष्प का दर्जा प्राप्त है। बिश्नोई टाइगर फोर्स के संगठन सचिव ओम प्रकाश लोल ने कहा कि यदि पेड़ों के 'हत्यारों' के खिलाफ कोई कार्रवाई नहीं की गई तो वे आंदोलन शुरू करेंगे। लोल ने दावा किया कि जोधपुर के पास मथानिया के जुड़ खारी गांव में भी खेजड़ी के पेड़ों को इसी तरह से हटाया जा रहा है, जहां 300 बीघा भूमि पर सौर ऊर्जा संयंत्र लगाया जा रहा है।

## दुनिया भर में 27.2 करोड़ बच्चे नहीं जा पा रहे स्कूल

नयी दिल्ली@एजेंसी। वैश्विक स्तर पर स्कूल न जाने वाले बच्चों की संख्या अब 27.2 करोड़ होने का अनुमान है, जो पिछले अनुमान से 2.1 करोड अधिक है। यनेस्को की वैश्विक शिक्षा निगरानी टीम (जीईएम) ने यह जानकारी दी। जीईएम ने अपनी हालिया रिपोर्ट में आशंका जतायी है कि 2025 के अंत तक देश अपने राष्ट्रीय लक्ष्यों से पिछड़ सकते हैं। रिपोर्ट में कहा गया है, ''इस वृद्धि के दो कारण हैं। पहला, नए नामांकन और उपस्थिति के आंकड़ों में कमी। 2021 में अफगानिस्तान में माध्यमिक विद्यालय में लड्कियों के जाने पर प्रतिबंध भी इस वद्धि में योगदान देता है।'' इसमें कहा गया, ''स्कूल न जाने वाले बच्चों की संख्या में वृद्धि का दूसरा कारण संयुक्त राष्ट्र के अद्यतन जनसंख्या अनुमान में बढ़ोत्तरी है जिससे ऐसे बच्चों की संख्या 1.3 करोड बढ गईं।''

रिपोर्ट में यह भी कहा गया है कि संघर्षों के कारण स्कल न जाने वाले बच्चों की संख्या को संभवतः कम करके आंका गया हो क्योंकि संघर्षों के कारण आंकडे एकत्र करने में बाधा उत्पन्न होती है। कुल मिलाकर, प्राथमिक विद्यालय जाने योग्य आयु वर्ग के लगभग 11 प्रतिशत बच्चे (7.8 करोड़), निम्न माध्यमिक विद्यालय जाने योग्य आयु वर्ग के 15 प्रतिशत बच्चे (6.4 करोड़) तथा उच्च माध्यमिक विद्यालय जाने योग्य आयु वर्ग के 31 प्रतिशत किशोर (13 करोड़) स्कूल नहीं जा पा रहे हैं।
