हड़ताल के चलते सैण्ड स्टोन का लदान बंद होने से एक्सपोर्टर्स की चिन्ता बढ़ी

प्रदेश में गिट्टी तैयार करने वाले क्रेशर मालिकों की अनिश्चितकालीन हडताल के कारण अब भवन निर्माण कार्य प्रभावित होने लगा है तथा पत्थरों की खदानों में खान मालिकों द्वारा काम-काज बंद कर देने से खान श्रमिकों एवं दिहाड़ी मजदूरों के समक्ष मजदूरी का संकट खड़ा होने लगा है। इससे सीमेन्ट की डिमांड घट गई है तथा कई कम्पनियों के गोदामों में सीमेन्ट का भारी स्टॉक जमा हो गया है।

हड़ताल को लेकर भवन निर्माण के कार्य में लगे ठेकेदार सबसे अधिक चिन्तित है। रक्षाबंधन का त्योहार निकट है। भवन निर्माण के लिए कच्चा माल उपलब्ध नहीं होने से मजबूरन निर्माण कार्य बंद करना पड़ा है। बिल्डिंग निर्माण के कार्य में लगें ठेकेदारों का कहना है कि हड़ताल नहीं टूटने पर हजारों श्रमिक त्योहार पर अपने घरों को लौटना शुरू कर देंगे। इस बीच अगर हडताल समाप्त भी हुई तो निर्माण कार्य 15





पर गए हुए श्रमिक हफ्ता-दस दिन घर पर रहने के बाद ही लौटते हैं। गिट्टी उत्पादन करने वाले कुछ क्रेशर मालिकों द्वारा हड़ताल के बाद भी चोरी-छिपे गिट्टी की सप्लाई करने की जानकारी सामने आई है। इसे रोकने के लिए संगठन के स्तर पर प्रयास किये जा रहे है। जिले के समोड़ी बनेड़ा तथा मांडल क्षेत्र में चुनाई पत्थर की सैंकडों खदानें हैं। जिले के बिजौलियां में सबसे अधिक सैंण्ड स्टोन की खदानें हैं। बिजौलिया में वर्षा पत्थर निकालने का कार्य दीपावली तक बंद होने का खतरा रहता है।
